### What is your vision for VLS in the next five years?

I want to see VLS reconnect with its roots and regain its crown as the finest Environmental Law School in the country. I want to see the alumni body rally around and reinvest in the school that we love and I want the administration to understand the unique relationship the alumni have with the school and with each other. A relationship not built on prestige and name recognition, but one built on grit, and getting runs in before class and literally housing and feeding each other and rebuilding together as a community after the storm.
